REForce Xi'an Branch HRnetGroup's 16th City of Operation in Asia & 7th in Mainland China

The Board of Directors of HRnetGroup Limited is pleased to announce the successful registration of the Xi'an branch and procurement of the local recruitment licence of its subsidiary REForce (Shanghai) Human Resources Management Consulting Co., Ltd (*REForce*), to expand further in China. This marks the incubation of the Group's 16th city of operation in Asia, and 7th city in Mainland China now covering Shanghai, Suzhou, Beijing, Xi'an, Chengdu, Guangzhou and Shenzhen.

REForce Xi'an is the latest organic expansion of REForce's professional recruitment business which the Group had acquired 51% interest in 2018. Over the last 4 years, REForce has seen its heartcount grow 200% to 120. The successful partnering has inspired the establishment of the REForce Chengdu branch last year and spun off a new JV unit RecruitFast Shanghai this year.

Xi'an is the second most populous city in Northwestern China, with a population of 13 million people. With a GDP of CNY 1.15 trillion, it is the largest economy in the Shaanxi province, known for the science, technology and engineering industries. Home to 120 semiconductor design companies whose products communications, storage, and the internet of things, Xi'an has the reputation of a leading city for scientific research that is backed by 60 local universities producing a strong pipeline of talents for cultivation into a costeffective and highly skilled workforce. The government's efforts in developing Xi'an as the core hub to advance the opening up of the Shaanxi province will create huge opportunities for stronger investment and trade.
